Academic Programs and Course Changes

# **Item Description**

This item presents proposed changes in curriculum for 2015-2016.

# Overview and Background

The Academic Planning Committee Curriculum members review and make recommendations for Board approval for new programs and courses. Due to recent changes by the State Board of Education that require the lengths of programs to decrease to 60 credit hours, there are several new programs that are being proposed that will replace the current programs of 63 or 64 credit hours. The lengths of programs are determined by the State Board of Education based upon recommendations from the colleges.

This item also presents the ten courses (30 credit hours) of upper division courses to be offered as part of the BSN degree that has been submitted for your approval in another Board item this month. Courses in the BSN will not be offered until February 2016 after approval by both the State Board of Education and the Southern Association of Colleges and Schools--Commission on Colleges are obtained.

## Past Actions by the Board

The Board approves the curriculum changes each year. Most changes were presented in the Spring for 2015-16. These are additional changes requested because of new state rules and the pending BSN degree. The changes are for the 2015-2016 academic year.

# Funding/Financial Implications

Current curriculum changes require no new funding. Expenses for the new BSN are included in the annual budget and are offset by tuition revenue.
