SUBJECT: Grants and Contracts - Provider

Item Description

This item requests that the Board approve the receipt of funding for the listed projects.

Overview and Background

The following are recommended for approval:

I. Receipt, Amendment, Extension of Resources

Florida Division of Emergency Management - Mobile Home Tie-Down Project

This award is to provide administrative support and implement the Mobile Home Tie-Down Project as described in Section 215.559, F.S., which provides inspections and improvements to tie-downs for mobile homes. The goal is to reduce property damage from high wind events. The amount of this appropriation is \$2,800,000, including an indirect cost rate of 5%. The funding period is from 7/1/2015 through 6/30/2016.

Florida Department of Education - Carl D. Perkins Postsecondary Vocational Education Program

This award is to provide direct student support services and job placement for disadvantaged/special needs students. This project helps to develop academic, career and technical skills of students who elect to enroll in career and technical education programs. The amount of this award is \$365,004, including an indirect cost rate of 5%. The funding period is from 7/1/2015 through 6/30/2016.

Florida Department of Education – 21st Century Community Learning Center Project

This award is to improve student achievement through after school and summer programs for at-risk students in Gadsden County attending Carter Paramore Academy and Havana Middle School. This will be achieved by establishing a community learning center, providing academic enrichment and cultural/recreational activities and engaging adult family members of students. The amount of this award is \$403,968, including an administrative rate of 5%. The funding period is from 8/1/2015 through 7/31/2016.

Florida Department of Education – 21st Century Community Learning Center Project

This award is to improve student achievement through after school and summer programs for at-risk students in Wakulla County attending Wakulla Christian School and public area schools. This will be achieved by establishing a community learning center, providing academic enrichment and cultural/recreational activities and engaging adult family members of students. The amount of this award is \$536,088, including an administrative rate of 5%. The funding period is from 8/1/2015 through 7/31/2016.

Big Bend Community Based Care - Fostering Achievement Fellowships

This award is to provide a staff position that will assist administratively with providing financial, academic and social support for college bound youth aging out of foster care that wish to pursue a college education. The amount of this contract is \$30,000, with an indirect cost rate of 0%. The funding period is from 7/1/2015 through 6/30/2016.

Florida Department of Education –English Literacy/Civics Education for Gadsden County

This award integrates education services to immigrants and other limited English proficient populations in Gadsden County to acquire the basic skills they need to function effectively as parents, workers and citizens. The award is for \$25,619, including an indirect cost rate of 5%. The funding period is from 7/1/2015 through 6/30/2016.

Florida Department of Education – Adult Education and Family Literacy, Adult General Education (Leon County)

This award will provide voluntary adult education and literacy services in Leon County in order to increase performance measures on standardized testing and obtain the educational skills necessary to be involved in the education of their children. The award is for \$75,028, including an indirect cost rate of 5%. The funding period is from 7/1/2015 through 6/30/2016.

Florida Department of Education – Adult Education and Family Literacy, Adult General Education (Gadsden County)

This award will provide voluntary adult education and literacy services in Gadsden County in order to increase performance measures on standardized testing and obtain the educational skills necessary to be involved in the education of their children. The award is for \$136,643, including an indirect cost rate of 5%. The funding period is from 7/1/2015 through 6/30/2016.

Florida Department of Law Enforcement – PTLEA Region III Trust Award

This award will provide the Criminal Justice Standards and Training Commission (CJSTC) with approved advanced and specialized training courses through Florida Public Safety Institute for local law enforcement officers. The amount of the award is \$92,460, including an indirect cost rate of 5%. The funding period is from 7/1/2015 through 6/30/2016.

Florida Department of Law Enforcement – PTLEA Region XV Trust Award

This award will provide the Criminal Justice Standards and Training Commission (CJSTC) with approved advanced and specialized training courses through Florida Public Safety Institute for local law enforcement officers. The amount of the award is \$249,977, including an indirect cost rate of 5%. The funding period is from 7/1/2015 through 6/30/2016.

II. Commitments, Expenditures, Contracts for Services

Mobile Home Tie-Down Project – Windstorm Mitigation, Inc.

TCC will require contractual services from Windstorm Mitigation to provide services for the Mobile Home Tie-Down Program to assist in securing manufactured homes to the ground. The amount of this contract is \$2,600,000. The contract period is from 7/1/2015 through 6/30/2016.

Past Actions by the Board

The contract with Windstorm Mitigation, Inc. was originally awarded based on RFP# 2012-02, which was approved by the Board on November 21, 2011. The option to extend contractual services with Windstorm Mitigation, Inc. is being exercised, which will extend the vendor contract through this funding period.

Funding/Financial Implications

The above projects will be established in Fund 2, Restricted Accounts. The indirect earned from these awards will be \$252,395.
