Academic Programs and Course Changes

Item Description

This item presents proposed changes in curriculum for Spring 2019.

Overview and Background

The Academic Planning Committee Curriculum members review and make recommendations for Board approval for new program and courses. Due to changes by the State Board of Education as well as the revision of programs to meet workforce demands, there are several changes that are being proposed.

The College is proposing a new Associate in Science degree program: Digital Media. The program is 60 credit hours and will provide opportunities for students interested in interdisciplinary digital media. Students will be able to obtain employment as a digital media/multimedia programmer, digital media/multimedia project manager, web designer/web production artist, audio visual technician/audio technician, lighting technician, graphic animator, videographer/editor, video engineer, digital media/multimedia producer, technical director, instructional designer or interface designer. There is a projected 6.1% growth for the region of Leon, Gadsden, and Wakulla and 26% growth for the state of Florida. The salary ranges from \$42,230 to \$66,130 according to the Department of Economic Opportunity. There are no fees associated with the new courses for this degree.

TCC is also proposing three new college credit certificates: Child Development Early Intervention, Infant and Toddler, Preschool Specialization. Students will be able to obtain employment as preschool teachers, childcare/infant toddler teachers, and teaching assistants in early childhood education. All three specializations offer industry certifications with a projected 11.8% growth for the region of Leon, Gadsden, and Wakulla and 12% growth for the state of Florida with salaries ranging from \$17,760 to \$45,340. There are no fees associated with the new courses for this degree.

Additionally, the Florida Department of Education requires courses not taught for five years to be deleted (6A-10.0331). TCC is proposing to delete several courses due to not being offered due to continuous low enrollment.

Past Actions by the Board

The Board approves the curriculum changes each year. The changes are for Spring 2019.

Digital Media, A.S. (60 credit hours)

This AS degree will provide opportunities for students interested in interdisciplinary digital media. Students will be able to obtain careers as a digital media/multimedia programmer, digital media/multimedia project manager, web designer/web production artist, audio visual technician/audio technician, lighting technician, graphic animator, videographer/editor, video engineer, digital media/multimedia producer, technical director, instructional designer or interface designer. There is a projected 6.1% growth for the region of Leon, Gadsden, and Wakulla, 26% growth for the state of Florida, and 12% growth for nation employment projections. The salary ranges from \$42,230 to \$66,130 according to the Department of Economic Opportunity. TCC currently owns the equipment that will be used for this program. There are no industry certifications associated with this certificate program and no lab fees associated with the courses.

There is a projected 11.8% growth for the region of Leon, Gadsden, and Wakulla, 13% growth for the state of Florida, and 7% growth for national employment projections. The salary ranges from \$18,500 to \$45,340 according to the Department of Economic Opportunity. There is an industry certification associated with this certificate program and no lab fees associated with the courses.

There is a projected 11.8% growth for the region of Leon, Gadsden, and Wakulla, 15% growth for the state of Florida, and 6% growth for national employment projections. The salary ranges from \$17,760 to \$27,750 according to the Department of Economic Opportunity. There is an industry certification associated with this certificate program and no lab fees associated with the courses.

Preschool Specialization Certificate (12 clock hours)

The salary ranges from \$20,060 to 35,840 according to the Department of Economic Opportunity. There is an industry certification associated with this certificate program and no lab fees associated with the courses.
