Item Description

The following is a request for the TCC District Board of Trustees to consider accepting pieces of artwork that were donated to TCC Foundation.

Overview and Background

A gift of art objects has been accepted by the Foundation in accordance with Policy No. 209A. The TCC Fine Art Exhibition and Collection Committee reviewed the pieces and recommend acceptance as long as the gifts were given free of donor-imposed restrictions. The TCC Foundation Board of Directors voted at their November meeting to accept these pieces based on the recommendation of the TCC Fine Art Exhibition and Collection Committee. The donor has signed an agreement with the Foundation relinquishing control of the pieces to the Foundation.

The Foundation is now offering the following pieces to the College and will transfer the gifts if approved.

- 1. Eagle, an ink drawing on rice paper piece by Roland Hockett, valued at \$1,500
- 2. Kimono Cow, an acrylic on paper piece by Ron Yrabedra, valued at \$3,500
- 3. The Emperor, an acrylic and gold leaf on paper piece by Ron Yrabedra, valued at \$3,500
