## **Budget Update**

Mike Fraser updated the council members on the current budget position. The current fiscal year ends on June 30, 2025. The current budget position has overspent by approximately \$900. As actual costs are received from the final classes, that number is projected to decrease. FPSI will pay any excess expenditure to help ensure all funds are expended.

### **Commission Updates**

Executive Director Hartman presented the updates from the CJSTC commission meeting on May 11-15, 2025.

- Lethality assessment training (legislative mandate) must be completed by June 30, 2026, and can be located on the FDLE training website.
- A discussion was held regarding whether physical fitness standards (contact hours) could be transferred to other training centers.
- FPSI was recertified as a CJSTC-approved training center.
- The Commission approved a shotgun and rifle operator/instructor course and added it to the list of specialized training classes. Any officer carrying a rifle and/or shotgun must qualify with the said weapon beginning July 1, 2026.
